I/We hereby apply for vendor space in the Vale Chamber of Commerce "Oregon Trail Days" (hereinafter "event") to be held at the Wadleigh Park on the above-referenced date. I/we agree to adhere to all terms and conditions of the event set forth by the Oregon Trail Days Committee and Chamber Board.

Lawn Spaces: The Vendor fees for the 2016 are \$35.00 for 15ft space and \$60.00 for 30ft space. If your display is over 30 feet, you will be required to rent two (2) spaces. Your deposit must accompany this application. Applications are first come basis.

Food Vendors: Vendor space will be \$75.00

Power: Power will only be able to accessed for Food Vendors

Set up: Vendors can start setting up June 30th after 5:00pm but must be set up by 12:00pm July 1st, 2016

Take down: No vehicles are allowed access to the lawn once the events begin. Take down loading can begin at 8pm Monday evening

Event Hours: I/we understand that the event is open Wednesday through Saturday. As a vendor, I agree to have my display open from 11am-8pm, Saturday through Monday. If I fail to be open during these hours, I may be asked to leave the event.

Display requirements: We reserve the right to remove any items, signs or people who demonstrate poor taste or conduct at the event. If the Oregon Trail Days committee or Chamber Board feels you or your display does not meet these requirements, you may be asked to leave. In the event this occurs you will be refunded one half of your vendor fee.

General Considerations and Restrictions:

- The Vale Chamber of Commerce will not be responsible for loss or damage to any vendors' items or vehicles.
- Dogs must be on a leash at all times; you must clean up after your dog at each time.
- Generators may not run between 10pm and 9am
- No one may sell items at the park during the event without a valid signed contract. Please do not support any solicitors who come to the show without a valid contract.

Cancelations: If you cancel before June 15, 2016, you will receive a refund of \$30.00 per 30ft space (\$15.00 per 15ft space). After June 15, 2016 there will not be a refund.

Late registrations: All registrations must be paid in full by June 15, 2016, unless prior arrangements have been made. This deadline can be extended up to 10 days, if payment is not received within that time frame, the space would no longer be reserved.
